Achievements: Expansion of ozone garden program with biomonitoring taking place during the summer months at schools; clean air clean water film festival to educate the public about the connections between air and water pollution; education campaign promoting public transit programs as a strategy for reducing vehicle pollution in urban areas; Particle Falls, an art/science installation in uptown Charlotte for seven weeks to educate the public about invisible particle pollution.

Medical Advocates for Healthy Air (MAHA)

Achievements: Education and advocacy at the state level by medical and health professionals for clean air rules and regulations; Promoted a clean construction policy for use by Novant Health on their construction site for a new women's center reducing fine particle pollution by over 40%; developed an accredited educational webinar for medical and health professionals and others about the health impacts of air pollution and climate change; sponsored the 2nd NC BREATHE Conference about the intersection of the health, environmental and economic impacts of air quality and climate change with over 150 scientists, medical researchers, economists, students, and government officials in attendance.

AirKeepers Citizen Science Program
